### SUMMARY

The suction characteristics of the Adelaide pleistocene clay in the remoulded, and undisturbed state are examined in detail. By taking densities of samples at the insitu ambient suction, and after equilibrating at a controlled suction, a relationship between density and suction has been established. These densities have been converted in many cases to void ratios to give a consolidation curve for the material. These curves, when compared with those obtained in the consolidometer, illustrate the difficulties encountered if attempting to compute settlements on unsaturated or quasi-saturated materials. A way of overcoming this problem has been suggested.
