# **EDITORIAL**

After a very confused On Dit last week, I am trying to get it all back together. The elections caught me unawares - not in so much that I didn't know they were coming up but that I had planned a full On Dit without them. Hence when they took an extra four pages, the editorial and news pages were axed. A very confused 'On Dit' was the result. It lacked continuity from the issue before.

Kerry Hinton's article, I hope raised some good points in relation to what people can get out of university life. Perhaps it might even have encouraged a few more students to come to student meetings and vote in elections, or may be even read articles in 'On Dit'. Quite honestly, I sometimes wonder how many people do actually read it. The people who work around here assure me they dobut it is just so hard to ascertain, unless I get some reaction from people. I have on occasions written what I considered to be outrageous things, calculated to get some reaction - but alas no-one noticed. I'm sure that if I said I was going home to suicide, someone would possibly be motivated three

weeks later to tell me it's not a sensible thing to do. On Dit tries to get out information and ideas, but it can never be the end of it. As Kerry's article suggested, the thing to do is read and learn, b try and do something about it too. There are many people working here who try hard to add to information available but they do rely on students actually walking to the places where events are arranged. For example two items discussed in on Dit are the issues of civil liberties in Queensland and the new ASIO Legislation. Next week they will both be followed up with forums and discussions. Speakers from Queensland will be on the lawns on Thursday to

talk about the March bans in Queensland and on Tuesday the Politics department is arranging discussion of this legislation. These are important issues and they do concern you. Evidence which came out during the Silisbury affair demonstrates clearly that ASIO and secret surveillance does affect us directly. You can be assured that if you have ever gone in a demonstration, gone to socialist party bookshop or meeting, or indeed in any way supported any left-wing or antigovernment protest, you have made it to ASIO files. I'm sure I've made it, I'm sure my father has too, and it's supposedly in the interests of the nation that we

be subject to surveillance. Who is deciding what is in the nations interest? In any democratic country we are supposed to be able to voice our opinion. This legislation will enable ASIO to control those rights. Make no mistake, the new legislation can only enforce the notion that any criticism is not in the interests of the 'nation'. What ASIO has been doing illegally for years it will be doing legally under sweeping powers reminiscent of Chilean fascism or the West German Berofsuerbot. It is important to understand the legislation, see what it does and OPPOSE it.



AUS (now Student) Travel ENT TRAV

After a national vote taken on Australian Campuses, AUS travel has now been sold. it is now owned by World Travel and will now be operating under the name of Student Travel Australia.

What the deal means for AUS in money terms, is \$12,500 now, \$12,500 next year and a further \$25,000 next year and a further \$25,000 in the following years providing the company is trading profitably.

AUS student travel is still a registered company (on the books) and AUS is still the sole shareholder At present its only operation is in suing its auditors (the ones who made the big mistake in the first place). Under the agreement AUS student travel will initially receive 200,000 and 50% of any profits thereafter. This will go towards paying off its debtors. At the stage, if profits are sufficient to pay off debts, eventually any profits would come back to

The whole deal is beneficial to AUS in many ways. Firstly we can ensure that a travel service continues to operate for students. Secondly under the agreement AUS has effectively

more say in the way the company runs than it did with AUS travel as run by the creditors. The agreement states that they will not advertise or promote travel to South Africa, advertise in a sexist or racist manner or in any way which conflicts generally with AUS policy. The agreement will be invalid if agreements are sees AUS policy having far more influence than it ever did under the scheme of creditors for AUS the Union can receive now.


The motion to be debated and voted on is the following.

This is another in the series of motions from AUS Annual Council that have come up for constituent ratification.

# Abortion and Health Funds



After protracted debate the motion proposed by Federal Parliament member for

Mr. Lusher was eventually defeated. The motion eventually passed was an amendment by member McMillan. It essentially said, that the Commonwealth government should not pay medical benefits for the termination of pregnancy unless the procedure followed was in accordance with the laws of the state or territory. This was carried 62 to 52.

Many parliamentarians, both Labour and Liberal effectively argued against the whole concept of the motion, in that it was nothing more than a dishonest attempt to make abortion impossible, after defeats on attempts to make it illegal. One speaker described the motion as a devious and unprincipled and an essentially illegal way to make legal abortions illegal. However, it is disappointing to recognise that the argument which seemed swayed was that the federal parliament should not legislate over and above state laws (hence the motion).

However, it is hard to say really what were the motives of all those people who voted. Members from both sides of the house recognised what the motion effectively did. It stopped poorer women getting legal abortions but not richer

women. It destroyed the concept that a woman citizen had any right to self determination and to make her own choices. This is and has essentially been the point of the abortion debate in other places and times. It is also one of the few issues upon which parliamentarians have a 'conscience vote' - after all what has their conscience got to do with a woman, or indeed any citizen, making their own moral decisions? In voting for the motion parliamentarians were making a moral ruling on thousands of women in Australia. As one speaker pointed out, it effectively connected together, what had always been assumed to be separate in Australia, church and state.

Perhaps the debate did some good if these issues were clarified for members, however, what is now more important is for State governments to attend to womens' needs in this area. legalization in the states and setting up of safe, controlled facilities, will be the way in which 'democratic' governments can allow all women to make their own decisions. If a moral move is necessary then it is to work towards increasing the safety of, and information on, contraceptives and sexuality so that the necessity for abortions can effectively diminish.

# French Study Tour

Ever dream of spending your holidays living in a chateau near Paris? Of meeting French people who share your special interests and learning to speak to them fluently in their own language?

South Australians will be able to do just that next summer, thanks to an innovative study tour organized by lan Laurie, our Professor of French, with the help of the French Ministeries of Education and Foreign Affairs.

Professor Laurie has arranged for the prestigious International Institute for Pedagogical Studies in Sevres to provide a wholly new 'total immersion' course in French language culture.

It is especially designed for Australians who want to improve their French by living and studying overseas but who lack the formal or professional qualifications - or simply the time or money - to participate in existing academic programmes.

The course runs from 20 January to 17 February 1980, and is open to any adult who already knows a little French.

And it's a real bargain: all transportation, including

international airfare, full-time tuition, and full room and board at the Centre's comfortable 18-century chateau. (Once owned by Mme. de Pompadour) are included in the \$1,600 fee.

In addition to formal language instruction by audio-visual and audio-lingual techniques, students will have a unique opportunity to pursue their own special interests in field projects organized by the Centre.

Those wishing to stay on in Europe at the end of the course may do so at their own expense.

The Centre's staff are worldfamous for their innovative work in audio-visual language teaching. Their recent film series on French culture, les Chroniques de France, is required viewing for South Australian Matriculation candidates in French, and is used at Universities in both Australia and New Zealand.

# Malaysian Airlines Boycott

Release by the National Executive of the Malaysian Union of Students in Australia Concerning TWU Industrial Action over MAS Workers' Strike and the Jailing of Union Officials and Workers in Malaya.

The Malaysian Union of Students in Australia (MUSA) today warmly congratulated and thanked Australian workers in Sydney involved in the black ban on a Malaysian Airline System (MAS), dc-10 airliner for continuing their black ban, despite blackmail threats from the fascist Kuala Lumpur regime. Although the airliner has now departed with help from the RAAF, MUSA urges Australian workers to continue a general black ban on MAS and to extend this to a general trade embargo against the fascist Hussein-Mahathir regime.

MUSA also urged the Australian Government to adopt a firm attitude against the fascist Hussein-Mahathir regime and welcomed its principle stand against the illegal arrest of Malayan workers and union officials working in MAS. Mahathir's usual lunatic ravings against the Australian workers, people and government is an insult to Australia. MUSA calls upon the Australian Government to maintain Australia's national dignity against the fascist Kuala Lumpur regime. Malayan people will strongly welcome the Australian people and government to teach the anti-people Hussein-Mahathir fascist regime a lesson. Retaliatory action by Australian people and government should be considered in response to the brutal treatment of Malayan workers and people by the fascist regime.

The black ban by the Australian workers particularly the Transport Workers' Union of Australia and several other unions is an act of solidarity with Malayan workers of the Airline Employees Union, who have been conducting a campaign of industrial action to obtain better wages and working conditions. Despite

record profits (M\$24 million last year), the Management of the MAS has further intensified exploitation of the workers. The Airline Employees Union has pointed out that the M\$154 (A\$61.60) a month basic salary for MAS lowest paid workers is much lower than the M\$195 (A\$78) a month, bottom scale for government workers. The demand of the workers to review the unfair wage scale has been arrogantly dismissed by the MAS management for years.

In 1965, the lowest income group in the Union was paid M\$139 (A\$55.60) a month and the government group figure was M\$90. Now 13 years later, the workers in airline industry have gone up a mere M\$15 (A\$6) a month and the public sector has gone up by M\$105 (A\$42) to M\$195 a month.

In addition to last year's record profit, this year's Domestic Load Factor has been over 90% and International Factors were averaging more than 75%. So profits for MAS are forecast to be spectacular.

In the course of the industrial action campaign, the fascist Hussein-Mahathir regime has brought into operation its entire battery of repressive legislation against the workers, 874 workers of the Airline Employees Union have been forced out of their own Union and the go-slow industrial action by the Union has been declared illegal by the fascist regime under the Essential Regulations 1969..(which constitute part of the notorious Internal Security Act). Only two months ago, the London Privy Council declared that the Essential Regulations are unconstitutional, illegal and ultra vires.

The puppet Ministry of Labour and Manpower has also ordered the suspension of the activities of the Union and has illegally frozen the Union's bank account. Further, individual crew members taking part in the go-slow industrial action were physically assaulted by the MAS Management senior officials.

When all else failed to break the stand of the Union, the fascist Hussein-Mahathir regime started arrests of Union officials and workers under the notorious internal Security Act which gives absolute power to the infamous Special Branch (i.e. secret police) to carry out indefinite detention of any person without trial. Incredibly, even the Asian Representative of the International Transport Donald Workers Federation, Uren, was also arrested by the Special Branch.

Several trade unions have come out in support of the Airline Employees Union, including the National Electricity Board Union. When four trade unions of Port Klang with a combined membership of over 10,000 workers threatened industrial action in support of the MAS workers, the Hussein-Mahathir fascist sent in armed troops to suppress the workers.


The Malaysian Union of Students in Australia said that the action by the Australian workers to black ban MAS is warmly appreciated by the Malayan people and urges the workers to persist in this struggle until all the union officials and workers of the Airline Employees Union are unconditionally released and the wage claims are met. This militant stand of the Australian workers wil contribute greatly to the development of friendship and solidarity between the Australian and Malayan workers and peoples.


MUSA further calls upon other Australian trade unions to join in all possible form of industrial action against the fascist Hussein-Mahathir regime.





By far the biggest issue in recent weeks has been the A.M. Compset 510 typesetter. After lengthy discussions in the Council, the issue was decided on the Barr Smith Lawns on Wednesday 21st. The decision of the meeting was to keep the machine (the vote was 149 for sending it back and 223 for keeping it).

Subsequent to this Union Council decided to buy the memory attachment (the floppy disc unit). Fortunately, quite a reasonable saving was made on this item due to quick decision by Council.

The participation in the decision made on the Barr Smith Lawns was quite pleasing, and hopefully will be continued.

# Catering Management Board (CMB)

On participation, the CMB is presently going through the process of acquiring its members for 1979. The CMB is a board of managers and determines the philosophies and management policies of the catering services the Union offers.

The "interested student" category of membership can easily include you, so if you have any strong ideas on what the Union's catering should or should not be doing, see either myself, David Muir (Union Secretary) or Peter Stark (Catering Manager). The CMB meets at 2.30 p.m. on a Thursday once per month.

Even if you can't be on the CMB, your suggestions are still welcome, just write them in the Suggestions Book in the Mayo Refectory.

## Vending Machines

Although many people don't like the idea of being served by a metallic box, these machines can provide food of quality equal to the food served over the counter. Apart from that, they can provide food after hours and on weekends for very little cost. These are some of the reasons. Union Council is looking at the possibility of installing such machines around the campus.

The proposal is in its infant stage, but it is being followed up fairly vigorously. The cost of installing these machines is fairly high but over enough years they will pay for themselves.

It is envisaged that these machines, if installed, would be strategically placed around the campus so that one would be handy no matter where you are.

#### **Priority List**

Each year the Union Council determines its priorities with respect to development of the Union. This priorities list includes any developments which require substantial amounts of money.

At present, the top position of major redevelopment is occupied by the Outdoor Eating Area/Wills Redevelopment plan. There are also other projects which have been proposed. These include; air conditioning, development of the Lady Symon Building and Western Annex, up-grading Union Hall, redevelopment of various areas within Union House.

This list is fairly important and any suggestions would be welcomed. One has to appreciate that the Union has a very limited amount of funds and an almost endless list of things to be done. Thus, deducing such a list is a fairly lengthy and complicated task.

However, below is the present priority list and once the new list is completed it will also be published.

#### Optimum Use of Union Rooms

Tied up with the priority list is how the Union can get the best use of the rooms it has available.

This issue is also being discussed currently and again any suggestions are welcome.

#### **Handicapped Students**

If you have ever had a hard time getting from point "A" to point "B" between lectures, just think what it is like for a handicapped student.

This doesn't just include people in wheelchairs, but also people with weak hearts, and other physical disabilities. Also there is a whole variety of disabilities which can make being a Uni. student much more difficult.

At present the Union is looking into these problems and in particular the Union Welfare Co-ordinator (Barry Heath) is undertaking amajor involvement in this.

One can only guess the number of handicapped people who have had to forgo a tertiary education purely due to the inconsiderate design of the institution. Although the number of such people may be small, the Union feels that losing just one is an injustice.

#### Invitations to Politicians

Over the last few years, there have been some actions by certain State and the Federal Government(s) which could be of detriment to the Adelaide University Union and have been of detriment to several other tertiary institution Unions.


In several instances these actions have been the result of what was occurring on campuses in those Unions. These reports were not necessarily 100% accurate and hence resulted in "over kill" situations.

To avoid this occurring with the Adelaide University Union and also to display what a typical tertiary institute Union does for its members, the Union Council has sent an invitation to all Federal Parliamentarians of South Australia.

So far the response has been fairly good, and further liaison is anticipated.

## Student Radio (SR)

Student Radio have experienced a boom in support and membership over the last several months. This has produced a problem of giving everybody in SR an opportunity to go through the motions of producing (etc.) a radio programme.



In an attempt to alleviate this situation, the Union has granted SR an increase in funding for 1979 so the SR may be able to extend its broadcasting hours and purchase some extra equipment.

SR will no doubt be advertising the new hours when they get the go ahead.

Another issue within SR is the payment of Student Radio Co-Directors. This issue involves the Students' Association since SR is a part of the Students' Association and hence the decision is theirs.

#### Constitutional Amendments

At present Union Council consists of 18 directly elected representatives with open franchise for all positions.

A proposal to revert to a representative Council will be considered by Union Council over the next few months. (Note: Union Council was until 1971 a representative body in that various sectors of the University had "x" positions which they filled).

The proposal is to have three groups represented on Council. The largest group will be those directly elected as at present. Then there will also be several academics chosen by University Council and several Union staff members elected by the staff.

Union Council considers this a fundamental change and hence will be studying it closely.

## Financial Task Force (FTF)

On the recommendation of the Union's Finance Committee, A Financial Task Force (FTF) has been set up to improve the methjod of producing the Union's Annual Budget. It is considered that in the past, the information used was quite insufficient for a competent budget to be produced.

It is also hoped that the FTF will help keep the Union Statutory Fee down by looking at possible income producing ventures and reducing the present costs of running the Union.

With respect to the "income producing ventures" in many instances these ventures could conflict with present member-oriented policies of the Union. In this respect, your opinion is vital to ensure the Union remains your Union.

Well, thanks for reading this column. Hopefully you now know a bit more of what's going on.

I apologise for the length of the article, but as you can see, a fair amount of activity is going on.

Finally, if there is anything you want to know about any of the matters discussed above, or anything you want to contribute, come and see myself or David Muir or any Union Councillor. (Their pictures are on display in the south-eastern corner of the Cloisters).

Your participation is not only desirable but vital.

FARMING and GARDENING - without poisons, in harmony with natural processes;

HUMAN RELATIONSHIPS and COMMUNICATIONS - covering such issues as sexism and with special emphasis on the situation of children;

PROGRESSIVE EDUCATION - emphasising the importance of educating people to help build the type of society they want and is of most benefit to them; EMPLOYMENT - ways we can find to support ourselves and live in our own means;

# Doing something about ASIO

Dear Nonee,

I refer to the article 'Experiences in Australia's Policing', On Dit 4.

While the article ended up by saying that the 1979 ASIO Bill 'must be opposed, and defeated', it did not say how this was to be achieved. To this end the Campaign Against the ASIO Bill 1979 (for want of a better name) was formed on the 24th of March.

The Campaign's main aim is to organize opposition to this bill, although one major obstacle already is the lack of publicity given to this issue by the established media. On March 8, the ASIO bills (there are 3 of them, with a related Customs Amendment Act) were introduced into Parliament. Yet while the importance of this bill is paramount, the Advertiser and the television stations after reporting on the bills on March 8 and 9, did not follow it up. As well as this the antics of Parliamentarians over the Lusher Abortion Motion took the spotlight away from the ASIO bill's second reading in the Senate.

What has been done to counter this by the Campaign?

- 1) a meeting has been arranged at 8 p.m. at the Box Factory, Regent St., City on Wed. April 4th for all people wishing to oppose these
- 2) A summary of the bills (attached) and a letter about the Campaign and the implications for Australian democratic freedoms have been produced.

3) Over a hundred organizations have been contacted to organize the latent opposition to these bills. Trade unions, political parties (ACP, Liberals, Australian Democrats, Communists and Socialist Parties), Church and ethnic groups. radio stations, student and community groups are all included.


How do the bills affect students and their organizations?

The powers given to ASIO under these bills will allow the tapping of phones and the bugging of houses, club rooms, people's workplaces etc. Information collected by ASIO can be given to Government departments thus potentially affecting students not only during their university days but also when they go looking for a job in the public service. On campus it may affect, the Students' Union, Clubs and societies and AUS depending on whether ASIO thinks that the activities of these organizations are affecting Aust. security.

Let us not be averse to seeing the full consequences of these bills. They affect us all in some way or another. Anyone and everyone interested in coming to the meeting is welcome. # GOVERNMENT TO SCREWSTUDENTS

What The Williams Report Means For You, The Student.

The Report of the Committee of Inquiry into Education and Training (known as the Williams Report) has many discussions and recommendations which will have effects on you, both directly and indirectly. However, due to the mammoth size of the Report (some 1500 pages), articles on the areas of greatest concern to you will appear in stages.

The recommendation which will most effect you is that concerning the re-introduction of tuition fees for tertiary education.


'R18.34 - The Committee recommends that the proposed Centre for the study of Post-Secondary Education Include in its program a study of the feasibility of a free system based on costs, and appraise the financial basis of Professor Blandy's proposals for reform'.

This recommendation may seem to have little immediate impact on you, especially seeing as the Centre for the Study of Post-Secondary Education hasn't even been set up yet. But, it is important that firstly, some of the more general impacts of tuition fees are made obvious and secondly, that a discussion of Professor Blandy's proposals for reform occurs.

#### **Tuition Fees**

The reintroduction of tuition fees will basically mean that less students will be able to attend tertiary institutions. There are two main philosophies behind this move, the first being that if less students are at tertiary institutions, then less money will have to be spent on education. Secondly it is also based on the premise that all people should pay for the educational services they receive.

What this really means is that only those who can afford to be educated, and not those who NEED or WANT to be educated. will have the opportunity to attend tertiary institutions. More specifically, those most affected would be 'part-time students, women, older students, country residents and students of lower socio-economic status'. At Adelaide University, at least one third of students (approx. 2,800 students) would be affected by the reintroduction of fees. No longer would education be the right of all people, no longer would the Government be maintaining the facade that everyone has an equal opportunity to higher education. Higher education would now become, once again, the realm of those people who have enough financial backing to afford it. Needless to say, some of those students who had enough wealth to attend tertiary institutions are no more intelligent than those who are

less well off. Higher education would be the privilege of those students who have 'money for brains'.

#### The Blandy Proposals

Professor Blandy, an economist from Flinders University was commissioned by the Inquiry to produce a paper on increasing the degree of availability of postsecondary education and training. In opposition to the University of N.S.W.'s survey, Prof. Blandy believes that the abolition of fees has not widened educational opportunities. U.N.S.W.'s survey found that the abolition of fees had in fact resulted in only a small increase in the number of students from poorer backgrounds attending. But, it also found that more than 25% of students from lower scrio-economic backgrounds would not have enrolled if tuition fees were charged. Apart from these basic facts, Prof. Blandy also forgets that there are many other educational, cultural, social, environmental and economic pressures which deter students from poorer backgrounds from entering tertiary institutions.

It is claimed that the reintroduction of fees and meanstested student finances (i.e. everyone gets a basic grant of \$2,500 and, wait for it, then a means-tested LOANS scheme) will (i) be more egalitarian, (ii) reduce the budgetary burden and (iii) restore a base of autonomy to institutions, while 'acting as a deterrent to any frivolous use of costly services.' Let's just talk about these bases for Prof. Blandy's scheme. Firstly it will not be more egalitarian as it means that those in the worst position financially, and who are also therefore less likely to take out a loan in these times of vast unemployment, for fear of not being able to cope with loan repayments, will not attend tertiary institutions. Those who are well off will not have to take out loans and will be able to enter tertiary institutions without having to 'compete' with those who have the capacity, but not the money.

Secondly, obviously it will decrease the budgetary burden. That is exactly what the current Federal Government wants. It seems that because the current economic policies have not been successful (except in increasing unemployment) education, and especially each individual student receiving that education, should become another of the Government's scapegoats which hide its own economic ineptness.

Thirdly, fees will not restore a base of autonomy to institutions. The University of Adelaide, through an act of State Parliament, is ALREADY an autonomous statutory body in its own right. The reintroduction of fees will not mean that institutions will have more money to control. The income which would be generated by fees would amount to little more than 15% of the University's annual budget at present - the remainder would still come from the Government. At the same time pressure would be exerted on institutions to 'wipe-out' courses which were not financially viable (because 3 they would not be generating enough fees). All this talk of autonomy is destroyed by another of Blandy's proposals which hints at giving the tertiary Education Commission (TEC) the legal power to withdraw accreditation from any institution 'which it considers has ceased to provide postsecondary education or training services meeting acceptable standards at fair fees', and he recommends that the TEC be given 'considerable powers to coerce the behaviour of institutions'. So much for the autonomy of institutions!!!

Finally, to state that institutions need a deterrent to any frivolous

use of costly services' seems a little farcical seeing that most institutions have suffered massive cutbacks in the past three years. Adelaide University is on a minus growth budget now. It has been given less in grants than in past years, contrary to the 2% growth promised during the 1977 election campaign. This sort of 'deterrent' thinking sets the atmosphere (as mentioned above) axing of courses which the University believes are necessary and worthwhile, but which 'monetarist' economists may consider 'financially unviable'.

# Prof. Blandy's Student Finance Scheme.

As stated before, all students would be financed by a flat grant of \$2,500, plus a means-tested student loan scheme. The inequities of this scheme have already been briefly mentioned. But, here comes the crunch. Fees would be charged according to the type of course the student wished to pursue. Consequently, fees for Medical, Dental, Engineering and even Science students would be

much higher than those for Arts or Law Students because of the amount of time and equipment used. Once again, this would make students from poorer economic circumstances think more than twice about entering into the Medical School for example.

Prof. Blandy also suggests that upon graduating, graduates of any tertiary institution should pay an extra tax, according to the number of years spent at the institution. This, he states, will ensure that those people who use educational facilities pay for them even more! Unfortunately, he neglects to remember that if a graduate does have the good fortune to score a 'well-paid' job as a result of his/her studies - they'll be paying more taxes anyway!!!

Well folks, that's basically it in a rather large nutshell I think the philosophy behind many of these proposals is fairly obvious - and I also think that, by and large - IT STINKS!! There's only one thing left - and that is for you - all of you - TO ACT: TO VOICE YOUR PROTEST!!

WHAT CAN YOU DO TO REGISTER YOUR PROTEST?

- (ii) Sign a petition (it will be available next week)
- (iii) Participate in the forums

  issues as they afect us all greatly.

As students, you cannot afford to stand by and allow this Report to be accepted and implemented by the Federal Government. The consequences would be disastrous. Show that you, as students, do not want tertiary education to be only for those who can afford it!!

# PROSTITUTION IN SOUTHAUSTRALIA

changed

Prostitution has always been for the press, a remarkably sensationalist issue: It's about time to try to examine it rationally in an informed light. At the moment a Parliamentary select committee of enquiry on Prostitution is sitting and it is expected to hand down its report to the State House of Assembly on November 9th. This year too, is the first year that AUS has ever attempted to have policy on Prostitution. In view of this, and the fact that all too many discussions of prostitution betray an only natural ignorance, On Dit looks at prostitution in Adelaide, the role of the government, and comes to some conclusions.

#### THE COMMITTEE OF **ENQUIRY**

What led to the setting up of this committee? Basically Robin Millhouse had a lot to do with it. Everyone has been aware that even if prostitution is not the world's oldest trade, it has certainly existed in Adelaide in almost every one's living memory. It used to be done under the name of escort services, and when the use of that name was banned it was done under the name of massage services. Mr. Millhouse massage parlour/services business, on the grounds that it was utter hypocracy for them to be so obviously operating, yet illegal. It was in response to this that the papers, The Advertiser and The News stopped all advertising. Now they all advertise in 'The Truth' - an interstate rag. Mr., Millhouse continued to point out that massage parlours weren't really offering massages and began to argue that if they were to be allowed to continue, they should be legalised. In June of 1978, a forum on Exploitation of Persons at which Mr. Millhouse spoke, and at which several prostitutes were in attendance was apparently the initiator of the setting up of a Prostitutes Union (later called the Scarlet Alliance). ### THE ARGUMENTS

To the arguments Mr. Robin Millhouse has stated quite definitely he favours (personally, not as a representative of his party) legislation. He favours this not because he sees any good in prostitution -

- 'I find the idea of Prostitution repellant.....So I am not here to suggest that there is any moral good in prostitution but I don't believe that it is my right to make a judgement for anybody else'2



Before continuing on with the debate between legalisation and decriminalisation, it may be worthwhile to describe what On Dit knows about the Adelaide prostitution scene.

Women working in prostitution fall into three basic groups in order of 'respectability': those on the streets, those in parlours and those working for services which often can be their own private number. Women in the streets, are of course, not easily contactable: they are considered by other workers to be the 'lowest' and there is a general attitude that they are either on drugs or too old to get a job in a parlour, although this isn't always true. Generally speaking it seems that their numbers are fairly small in Adelaide, Male prostitutes are rare but do exist, but mainly their work is involved with homosexuals.

Next are the parlours - these are what the laws describe as brothels. They exist all over Adelaide and vary considerably in size, conditions and ownership. The smallest can be run by one or two women to larger establishments run by a man or woman, with few employing above 20 people. As a general rule the ones run by women have better conditions, women are encouraged to use condoms, and have better facilities, particularly where the boss is a prostitute too. It seems too, that it is the ones which are run by men are more likely to be involved in other sorts of crime as either a front or supplementary income. The involvement of difficult to ascertain; it appears that most criminals involved are our own smaller Adelaide individuals, but there are cases where people working for parlours do not know who owns them. As far as can be gathered, it seems that police here have worked consistently, not to get rid of prostitution, but to get rid of associated crime where possible. It is believed that there was a move by Sydney big business to gain control here in 1976, but that police quickly sent the individuals concerned back. It is in these situations that the laws regarding prostitution are often utilised - to get at

search laws relating to brothels are often heavily utilized in this instance, effectively, searching without a warrant for anything from drugs to guns. This is

mostly the reason why parlours are likely to be 'busted' so often, although prostitutes are often charged in these instances, it means little more than a days disruption to their work However, the extent of heavy criminal involvement does not seem to be really high. The women would tend to be selective about working for such people, and it is often true that the women working for them have gone into prostitution to pay for drugs, and are more likely to accept bad working conditions and hours, as well as an often disrupted work schedule. However, as said before parlours vary widely and it is virtually impossible to make any statement which holds true

for all of them.

The third area of prostitution, is that of home services. These can be owned by an individual who has women working for him or her or can be a private concern which one or two people operate. This area is the more sheltered section of the business too. There are large numbers of women working in this area who have absolutely no criminal record - nor are they likely to get one. The people working here, often work as prostitutes unknown to friends, family and often have another job. They vary from working class women. who have been in 'the game' since they left school, to married women or supporting mothers who need more income, to students who supplement TEAS to wives of professional business men who charge very expensive prices and have a 'select clientele'. This variation is true for women from parlours too, although it would not include the more 'upper class' women. Part of the reason why many don't have 'records' is that it is these businesses which are straight prostitution services, have no involvement with other crime and therefore tend to be ignored by the police. The only way it seems that they can be caught is for police to 'set them up' - i.e. phone up, make a 'booking' meet

the woman and have her actually

A PROSTITUTE'S

As stated previously the number and type of women involved in prostitution vary greatly in Adelaide. All involvement is primarily for money, and large amounts can be earnt. None of the prostitutes whom On Dit has had contact with, came remotely near fitting Mr. Millhouses description. Many are uneducated women who have little or no chance of earning a decent income elsewhere, Large numbers have families or more often are supporting mothers trying to scrape by on a pension. Few thought that it was a good life, but most felt that they had clearly chosen it because it was the best that they could hope for at present. Some are in it to get money for a particular purpose and then get out; others see no way out in the near future. A very few say they enjoy the life.

The alliance of women who are involved in prostitution, stated clearly that they want decriminalisation - not legalization. In effect the repeal of the current laws, so that prostitution is not mentioned, so that the prostitute is no longer a criminal. They are especially concerned with the laws under the police offences act. Their concern is often not so much with the law itself, as it is fairly obvious that the police have never had any great intentions of stamping prostitution out, but with the way they are used and tially they feel that the practical use of the laws acts only to continue the oppression of women who are prostitutes, and that their criminal status allows them no protection either from or by the police.

For example, the way people are charged under section 63 of the criminal law consolidation act illustrates the hypocracy of the police position. A woman may advertise a position available, she will get applicants, if they happen to be police women. then she will be charged with procuring ( a seemingly wide definition of procuring). Yet as one service owner pointed out, when a prostitute is raped, and she described two instances where women were brutally

greater danger to the community than a rapist? Sometimes, she said the police were sympathetic but said there was nothing they could do, and anyway they'd lose in court. Needless to say, the women did not lay charges. However, even when the services became aware that a known rapist had been booked by one of them, they tried to get the police to set him up, but there were no police women who were prepared to go dressed as hookers to catch this man, so he got away. Of course, should an irate owner/husband/ boyfriend 'deal' with the man, the police would come down on them very hard and lay assault charges. This is what prostitutes see as the major thing decriminalisation could achieve - a woman carrying out an illegal act gets no protection from any other illegal act-if she was going about a job which was not illegal

The prostitutes league say that while they agree in principle with the sentiments in the criminal law act, they see it as unnecessary to have specific laws relating to prostitution in this area. They believe that it, as one among many occupations should not be singled out as all people should be protected from threat or fraud in any job. Similarly, with the protection of minors, it seems hardly sensible to 'protect' them in relation to one job only. As far as they are concerned the vast number of women arrested under these sections are 'set up' by the police (by procedures outlined above) and this to them is a ridiculous waste of time by the police, in harassing women who choose to make a living out of prostitution.

The problems which they face under the law are firstly as criminals they can not get protection from pimps, rapists, rip off etc., as legal citizens they want the rights of any others. The other major problem is that police utilize their non-legal status to threaten, harass and hurt the women too. They also by threatening to charge men whoparlours hire as body guards, who live off the earnings, and effectively remove

prostitutes can get themselves. This then allows them to utilize he laws as they wish - it is ominous that prostitutes when speaking of rape and assault and bashings by men do not distinguish between pimps, police or clients. This is not by nost of the women spoken to said they had been either raped assaulted at one time or another, and a large number were not at all happy with the police's attitude. Harrassment is also a large problem in relation to the police - all too often women have been maltreated, threatened with reporting to welfare when they have children, or telling of family - all of which seem unnecessary to say the least, aspects of police work. It seems that as they can legally search brothels, under existing law, at any time, their behaviour here has not been exactly legal either - descriptions of breaking, smashing,

The whole question of prostitution raises many difficult auestions for the womens' movement. Many years of argument have illustrated this. Some feel that the whole concept of equality is endangered by 'women who allow themselves to be marketable objects of sex'. However this is an attitude which should be rejected as over simplistic. It does not recognise that in this society, prostitution is not the only marketable object of womens' sexuality. In terms of hypocracy, it would not be incompatible with all else that this society condones to recognise and control prostitution. However the whole concept of legalisation allows only the woman to continue to be seen as the criminal - a legal controlled criminal. Women in this society who go into prostitution should be allowed the same protection and rights of any other woman in this society (such as it is). The client has never been prosecuted - an illustration of the fact that this society allows women to be used and condemned but does

As Feminists, we can never condone suppression or legalisation - both of which are ways in which women are made to pay for what is essentially an aspect of this socio-economic

It was an attempt to define this dichotomy that saw the womens' department's first attempt to have policy on prostitution. Due to the nature of council, the discussion was not extensive. However. hopefully, this article will be an incentive for people to think (and maybe write) about the whole issue.


4. AUS recognises that the legalisation of prostitution - the substitution of one act of laws with another - merely replaces one set of oppressors - the pimps and police - with another, the State. Further, in other countries where legalisation has occurred and Government controlled brothels have been instituted, official corruption and intimidation of prostitutes has become entrenched.

The book is an epic fantasy about rabbits. It is too much to hope that the film would include the depth of the novel. It is, however, a cut above the sickly Disney products. The animation is realistic, rather than symbolic (except for a section dealing with the legend of El-ahrairah) and quite will done. The film follows the story of the book closely, but unfortunately, rather than dealing with some of the fascinating mythology present in the book the producers chose to tell a straightforward adventure story. # The War Game

BANNED B.B.C. FILM

'The War Game' was made for B.B.C. Television by English filmmaker Peter Watkins in 1965, and since then has been banned from being shown on television anywhere in the world.

It is a graphic portrayal, shot in newsreel-cumdocumentary form of the consequences following the explosion of a Soviet thermonoclear bomb on southern England: thousands die from radiation within weeks, and thousands more are left physical and mental wrecks, with burnt eyes, appalling skin cancer and other mass radiation induced disorders.

The B.B.C. Ban was placed to forestall the problem of thousands of television viewers actually believing a nuclear attack was taking place. Psychiatrists had warned the BBC programmers that the film could possible induce some people to commit suicide.

Watkin's film is based on the aftermath of the WWII bombings of Dresden and Hiroshima. It is one of a number of social documentaries made by Watkins over the past 15 years (others include 'Privilege' and 'Punishment Park'), and he is acknowledged world-wide as a major innovator in television documentary formats.

Watkins visited Australia in July 1977 as a guest of the Sydney Film Festival where his most recent film 'Edvard Munch' was premiered.



- 3.5 To provide for social activities


To foster friendship and understanding between all students and their families.


Apollinaires libretto dates from 1917, Poulenc's witty music from 1944. A cheap effective theatre piece.



# The Crusaders

"Images" RCA: BA6030

This is an album of sublime excellence. It flows both musically and technically as a direct response to an all important aspect of sound - production. Consisting of totally original compositions "Images" upholds the acclaim of The Crusaders as innovators in a truly distinctive sound in popular music.

Side one eases into existence with the mystically evasive percussion talents of 'Stix' Hooper, an essentially consistent part of The Crusaders sound. From thence on its hard to say where one track ends and the next begins, the production is just so well measured.

Two tracks of particular interest, both on side two, are "Convert Actions" with lapses of lead and rhythmn guitar which show the great style of Billy Rogers while Wilton Felder on sax produces some ear catching electronic effects. The last track, symbolically named "Snowflake", has fast melodic riffs of sax and keyboards (Joe Sample). Of consistent quality throughout is the bass of Robert 'Pops' Popwell.

It is hard to single out any one ingredient which makes this album so good, so tight. Perhaps the most complimentary thing to say would be that it shows what can be achieved by working successfully as a team especially in this area of music. It is strictly modern music suited perfectly to the compositional talents of The Crusaders.

Rock n Roll may have been a geat sound for yesterday, and punk is the music of today's social order, but jazz rock is real food for Music appreciators.

"Images" is a reflection of The Crusaders ever-evolving musical sophistication, a reflection of gold.

Side one opens on the pleasantly catching melody of "In The City". The use of percussion vocals sets the standards to not unlike those of Michael Franks but lacking the catchy up tempo which Franks manages to maintain. Unfortunately the lack of any real meaning in the vocals results in loss of interest by track four, first side. Redemption is at hand however on the title track featuring interesting use of orchestral arrangements, and John Trapea's classical guitar on "Just A Friend" is worth staying awake for, as are the refreshing but all too frequent sax breaks by Almond. "Girl On Table Four" has Will lee on bass to pull it thru adequately enough. Even the titles seem to be saying the same thing only different phrases.

The lack of any feel in the words of the songs lets down the album musically as there is no relationship between vocal and instrumental (a lesson to be learnt from the Blues).

The sound overall dabbles between commercial and non-commercial. I could dare to say that at times it comes close to Como illusionists, but fortunately there is enough musical talent (at the hands of experienced musos) not to sacrifice it this far. A worthwhile disc to dance to 'Fonz' style, or to slip into your bedroom stereo.

If the early 70's produced anything significant in the development of rock music, it had a lot to do with Van Morrison and Neil Young. Both shunned conventional attitudes of the rock music/business world in favour of a dedication to their art. Both have had erratic careers to some extent, but the quality of these songs shows they have learnt to live with their successes as well as their failures.

'Natalla' is a soul-flavoured song, with a light jazzy touch, recalling Van's 'Moondance' era. Less commercial than 'Wavelength', but definitely The Man at his best.

It seems Neil Young only finds commercial success when he releases something sub-standard. If that's the case, 'Four Strong Winds' should be a dismal failure - it's a beautiful song, with Neil, and Nicolette Larsen duetting perfectly to a rich acoustic guitar/violin backing.





Southside Johnny, 30 years old, got his start in Asbury Park, New Jersey singing in bands like the Sundance Blues Band, Dr. Zoom and the Sonic Boom and the Blackberry Booze Band, bands which at times included the likes of Bruce Springsteen, Miami Steve van Zandt and various members of the Asbury Jukes and the E-Street Band. The Asbury Jukes came together as such in '74. Two albums followed: 'I Don't Wanna Go Home', and 'This Time It's For Real' - both containing the songs of Springsteen and Miami Steve along with some old R'n B tracks. 'This Time it's For Real', in particular, was brilliant, being immaculately produced and played and featuring some excellent Van Zandt compositions.

'Hearts Of Stone', their third album continues where the first two left off. The sound is more contemporary - a deliberate move by Southside and producer Miami Steve to widen their audience - but there is no compromise in the material. This time the songs are all new, again mostly from Miami Steve with Springsteen contributing a couple of tracks including the title track - a ballad which should become a classic, and is actually getting some airplay.

As with the last album, it takes a few listens for the songs to take effect - but the effort is well rewarded, as Southside Johnny and the Asbury Jukes have a timelessness, like those songs from the 50's and 60's which bear listening to over and over again.

Other standout tracks include the rocky 'Take It Inside', 'Got To Be A Better Way Home', and 'Trapped Again', a song Jo Jo Zep and the Falcons do a breathtaking version

Do yourself a favour and get into Southside Johnny and the Asbury Jukes.

# **Bad Company**

'DESOLATION ANGELS' - Bad Company

The trouble with 'Supergroups' is that their bubble usually develops a slow, whining leak once the novelty has eroded. I can remember days of Cream, Yardbirds, Blind Faith and Bad Company. Gone are the days when the legendary name of Free attached to the band used to pull in the crowds, gone are the days when Paul Rodgers vocals ranked only third behind Robert Plant and Ian Gillian. I keep a list at home of my favourite bands with little annotations next to them to mark their traverses through my fickle mutations of taste. Bad Company I noticed had joined the discard pile (with the other notables like Deep Purple) with the label, dare I say it, 'Defunct'.

So it was with awe and surprise that I'm confronted with a new Bad Company album, 'Desolation Angels'. My heart beats quicker as I notice the label of Swansong (the legendary great's Led Zeppelin's very own contrivance). My mind conjures up memories of the almost cult albums



of 'Bad Co.' and 'Straight Shooter'....the cover brings flashbacks of Floyd's 'Wish You Were Here' and Zepp's 'Presence'.

'Desolation Angels' could almost be a new Foreigner album - so clean, like chromium tubing - Mick Ralphs doing his Jimmy Page impersonations, crystal hard conciseness, 1975 revisited - adversely anachronistic. In 1979 there are at least three or four camps - punk, disco, jass rock and acoustic. Bad Co. is in the camp that caters adequately to antiques like myself who dwell in pre-disco pure Rock memorabilia. Apart from heavy foot-stompers like 'Rock'n'Roll Fantasy' and 'Evil Wind' there's slower (unusual for Bad Co.) ballad-like 'Take the time' and 'Early in the Morning' which sound like rivals to commercial Suzi Quatro of late. Lyrically deficient, perhaps 'Desolation Angels' really is just another rock pipe-dream. 'Lonely for Your Love' opening side two could be a contender for the rock'n'boogie prize alongside Quo's best efforts...ahl sweet memories. Perhaps the ideal party record of the '80's, who knows?

But I know exactly what I'm gonna find'.


From the opening bars of 'Going Down To Laurel' to the last track 'You Cannot Win If You Do Not Play', its obvious that Steve Forbert is not just another singer-songwriter following in Dylan's footsteps. He's original, slightly humorous, talented both as a musician and writer, and what's more you could swear he knows what he's singing about. To his credit, he doesn't take himself too seriously and his performance is all the more convincing for it. Included among the 10 fine tracks is 'Grand Central Station, March 18, 1977' a song about street musicians which recalls Joni Mitchell's 'For Free'.

'Think what you will, laugh if you like, It don't make no difference to me, I'll open my case, and I might catch a coin, But all ears may listen for free'.

Although the album features Forberts acoustic guitar and harmonic playing, he is helped out by an excellent band, and the sound is quite electric at times.

If comparisons must be made, Steve Forbert reminds me a bit of Canadian songwriter Murray McLaughlan, but like all good artists, he has his own sound so check him out for yourself.
