The retiring warden (Mr. Frederic Chapple), and the reliring clerk (Mr. T. A. The following matters will be considered: (1) Repeal of Chapter XIII. of the statutes of the "Angas Engineering Scholarship and the Angas Engineering Exhibitions" and a new Chapter XIII. to be substituted therefor; (2) Repeal of clause 2 of Chapter XVIII. of the statutes of "Academic Dress" and new clause 2 to be substituted therefor; (3) Repeal of clauses 1, 2, and 4 of Chapter XXII. of the statutes of the "Hartley Studentship" and new clauses 1, 2, and 4 to be substituted therefor; (4) Chapte. THE UNIVERSITY COUNCIL.

Dr. Helen Mayo is the first woman to be nominated for election as a member of the University council. There are six candidates for the five positions vacant, namely-Mr. F. Chapple, B.A., B.Sc., Canon Girdlestone, M.A., Mr. W. J. Isbister, LL.B., Miss Helen Mary Mayo, M.B., B.Sc., Professor Rennie, M.A., D.Sc., and the Hon. F. W. Young, LL.B. (Commissioner of Crown Lands). The election will take place at the meeting of the University Senate on Wednesday next. On the agenda paper is a proposal to include in the statutes a provision regarding scholarships in memory of the late Mr. John Creswell, and £1,300 has been paid to the University for this purpose. The South Australian Cricketing Association and the Royal Agricultural Society will award one annual scholarship each, and the University council will provide two. The first two scholarships are for students who have passed the junior commercial or senior commercial examination, and those awarded by the University council are for students who have passed the senior commercial examination in the year preceding the award.

-Miss Kleinschmidt's Career.-

The latest report of the Serena Trust gives interesting particulars concerning its asset-Miss Clara Kleinschmidt, The directors state:-The amount now standing at the credit of the company is £279. It is proposed to reserve £100 out of this to carry on the company, the balance (£179) to be spent in the further education and professional debut of Miss Kleinschmidt. This balance has already been remitted to London for that purpose. During the period under review Miss Kleinschmidt completed her studies at the Royal College of Music, and obtained her A.R.C.M. degree, with 31 marks above the ordinary pass. Since then she has been studying at Cologne, Germany, under Professor Schulz-Doenburg, who was one of the head teachers at the Conservatire Cologne until be formed a private school of opera of his own. He described Miss Kleinschmidt as the most talented pupil he ever had, and predicted a great future for her. Unfortunately, the professor died on the eve of his intended introduction of Miss Kleinschmidt to agents in Berlin, with a view to securing a professional engagement for her in grand opera. Miss Waite has,

in consequence, gone to Berlin with Miss Kleinschmidt, and a further report on the position and Miss Kleinschmidt's prospects may be expected shortly. Miss Kleinschmidt's student days are now nearly ended, and it is hoped that she will soon nake a successful debut.

UNIVERSITY COUNCIL ELECTIONS. From "M. A.": - "The generality of these elections resolves itself into either reappointment of the resigning members or co-operation of those of whom the members of the council approve. It is only on very rare occasions that any new blood is admitted. The fault of this lies partlyperhaps mainly-with the members of the senate, who fail to attend the meetings in any adequate proportion. The meeting on Wednesday next is of significant importance, since for the first time a woman graduate has accepted a nomination for a seat on the council. This is a new policy. and is therefore one on which it is desirable that the voice of the senate should be distinctly heard. If that shall be the case, and its decision shall run counter to my own opinion, I shall contentedly accept the position that the time is not yet ripe for such an alteration of existing practice. Personally I think the time has come for women to have seats on the governing body of the University. Long ago its portals were freely opened to both sexes, it has already a large number of women graduates, and has some hundreds of women undergraduates. In these circumstances it seems to me to be desirable, if not indeed imperative, that they should have some of their own sex in the council; and, if I may venture to suggest it, the council should meet a reform which sponer or later is bound to come, not with indifference, still less with opposition, but by so modifying present regulations that three or four of its seats shall be filled by women. As one who was admitted ad eundem at the foundation of the University, and who has watched with interest its wonderful progress, I shall bail the adoption of this reform as opportune and prudent."

UNIVERSITY LECTURE TO WORKERS.

The president of the Trades and Labor Council (Mr. T. Ryan) told the delegates last night that some time ago the question of getting University professors to address the council on industrial matters had been ranged. Professor Jethro Brown had told him that he intended to lecture at the University on "Syndicalism." He aasked if he could address the Trades and Labor Council on the subject if he could induce the University Council to agree to that course. Mr. Ryan said the professor had intimated later that he would be prepared to deliver the lecture on December 2 The report was received, and the offer of Professor Brown was accepted. The hope was expressed that this would be only the first of a series of lectures on industrial subjects. The secretary to the council is to let the unions know of the lecture.
