EDUCATION IN BRITISH COLUMBIA.

Mr. W. Howelin recently received from his daughter, Mrs. Parkinson, B.Sc., of Vancouver, an interesting newspaper extract referring to the foundation of the British Columbian University at Vancouver. In view of the critical attention which lately has been bestowed upon the Adelaide University, it is worthy of notice that the Columbian institution will enter upon its career splendidly endowed. Apart from provincial university lands, with an area of 2,000,000 acres, valued at from £1 10/ to £2 an acre, the university site proper consists of 177 acres worth practically £500,000, and it is intended to secure an additional 50 acres to provide room for the houses of the professors. The Premier has promised that £200,000 will be set aside from this year's Estimates to meet the cost of the construction of the main building. Tenders have already been called for the clearing of the site on which this structure will stand, and the Minister of Education (Hon, Dr. Young) is confident that the first classes will assemble in the early fall of 1913. Instruction in the arts course will be absolutely free, and students in the affiliated theological and technical colleges are to have all the advantages of such an arrangement. When a British Columbian perent places a child in the lowest kindergarten class, it will be with the understanding that nothing but a lack of inclination is to prevent that child passing through the grade and secondary schools and on to the attaining of a degree without fee or disbursement. "The department of education," remarked the Minister in a recent address, "will make it an object to educators to come to British Columbia. We are going to get instructors who are so wrapped up in their work that they will have no time for money making; the department will look after them. The days of undervaluation of tutorial services are past, and we shall make our salaries commensurate with the dignity of a professor's station in life." Continuing Dr. Young said the spirit of the affiliated educators of the province augured well for the advancement of learning in British In the present year the department had spent £400,000, the municipalities had disbursed £600,000, and, in addition, the private schools and colleges had governed the expenditure of large sumstruly a worth'y record in a portion of the Dominion that could muster not more than 300,600 souls. The Arts College was to be the centre pin of the university scheme; agricultural courses in connection with the model farm already established at Coquitlam, engineering, mining, and biological branches would receive immediate attention. It would never be the aim of the institution to turn out dry specialists in technical subjects as long as the influence of the broadly cultural features of the course could be em-

A meeting of the council of the Adelaide University was held on Friday afternoon, There were present the Chancellor, the Vice-Chancellor, Professors Lowrie and Rennie, Hon. G. Brookman, Dr. Stirling, and Messrs, G. J. R. Murray, A. Williams, Talbot Smith, S. J. Jacobs, and J. R. Fow-The Chancellor welcomed Professor Lowice as a member of the council, and greeted the Director of Education and the Registrar, who had been on extended trips, Dr. Cleland having resigned the dual lectureship in forensic medicine and lunacy, the council appointed Dr. C. Reismann as Lecturer in Forensic Medicine, and Dr. M. H. Downey as Lecturer in Lunacy. The following appointments for 1912 were approved:-Mr. D. Mahoney, B.Sc., Acting Lecturer in Mineralogy and Petrology during the absence of Dr. Mawson. Dean of the Faculty of Arts, Professor Henderson; Dean of the Faculty of Science, Professor Rennie: Dean of the Faculty of Law, Professor Brown; Chairman of the Board of Commercial Studies, Mr. J. R. Fowler; Chairman of the Public Examinations Board, Professor Rennie; Education Committee. Professor Lawrie was appointed a member: Faculty of Medicine, Mr. G. J. R. Murray and Professors Mitchell and Lowrie were appointed the council members; Faculty of Science, Professor Lowrie was appointed a member; Faculty of Music, Mr. E. E. Mitchell and Mr. E. Alderman were appointed members. Mrs. W. A Magarey was appointed a member of the Board of Medical Studies. The members on the other committees and faculties were re-elected. In consequence of Kerth Leask's readings from Carlyle (Blackie and Sons) being out of print, Bacon's essays by Edward Gaye (Clarendon Press) was substituted as a text book for the B.A. degree. An interim report from the Registrar in regard to the Universal Races Congress held in London in July last, and visits to Universities in the United iKngdom, were received.

The Hon. A. R. ADDISON seconded. The Council then proceeded to ballot, which resulted in the election of the Hons.

J. J. Duncan and Sir J. L. Stirling. The PRESIDENT-May I be allowed to say that I thank the Council for the expression of its confidence in electing me to a position which was entirely unsought and unexpected.
